3. CALL FOR FIRMS

MMH is seeking the services of a firm for consultancy services for incinerator installation. The firm will have relevant and verifiable experience in preparation of consultancy. Interested Firms are encouraged to submit their Request for Proposals (RFPs) and other supporting documents with information demonstrating that they have the required qualifications, competence and relevant experience to perform the assignment under the terms in the following sections.

4. TERMS OF REFERENCE

4.1 NATURE OF THE ASSIGNMENT AND SCOPE OF WORK

The successful bidder will be expected to develop and demonstrate adequate expertise on the assignment:

- i. The consultant should determine the ideal capacity of of waste incinerator for our waste disposal needs. The assignment will involve analysing the rate at which the volume of our incinerations waste has been growing in the last few years.
- ii. Advise on the disposal methodology of the decommissioned waste incinerator as recommended by NEMA.
- iii. Advise on the size and design of the housing shed that can accommodate the new incinerator or modifications that can be made to the existing housing structure if possible for the same purpose.
- iv. Advise on the design and recommend capacity of the proposed new incinerator including NEMA compliance requirements and any associated auxiliary equipment necessary for effective operation of the waste incinerator. The design parameters of the waste incinerator shall include technical specifications of the same, specifications and design of air pollution control system, design features of the flue gas sampling ports and access ladder.

- v. Assess possibility of installing a Waste Heat Recovery boiler that can harness the waste heat from the waste incinerator and advise the hospital accordingly. This is highly recommended for energy efficiency purposes.
- vi. Advice on alternative energy options available to facilitate operations of the incinerator.

4.2 SCOPE OF SERVICES

The consultant, being the lead partner, will work with consortium that is composed of other relevant experts. The consultant is required to:

- a) Prepare drawings and designs for, electrical, structural & associated works.
- b) Support preparation of tender documents.
- c) Support in evaluation of tenders
- d) Supervise the projects.
- e) Preparation of Bill of quantities plus summary budget for the works.
- f) Contract supervision that includes
 - Enforcing the projects' quality (Materials used and works), time & budget
 - Advising on contract interpretation, payments, scope of works & accounts etc.
 - Exercise cost control during construction;
- g) Co-ordinate site visit meetings and submit reports.
- h) Facilitate and provide hospital with any of the required local approval documents for the project.

5. THE KEY PROPOSAL FOCUS AND EVALUATION CRITERIA

5.1 KEY PROPOSAL FOCUS

The proposal shall provide the following information:

- (i) A brief description of the firm's understanding of the assignment;
- (ii) A brief description of the firm's organization and an outline of experience on assignments of a similar nature.
- (iii) A detailed description of the proposed advice and support to be provided including key deliverables.

(iv) A list of the proposed staff by specialty to be assigned to the hospital for this assignment indicating their education, training and experience.
